

#### ARCHITECTURAL DESCRIPTION:

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

615 Old Fall River Road DAR.660 is a one-story, five-bay wood frame Greek Revival residence. The residence faces south and is set back approximately one hundred feet from the road on a level lot. The building adopts a rectangular plan on a granite foundation. The residence terminates in a side gable roof sheathed with asphalt shingles. A full width shed roof dormer is featured along the north roof plane. The residence is clad with wood shingles. Access is provided by a centrally located entry door highlighted by a simple wood surround. Two 2/1 double-hung replacement window is located to each side of the door. Each opening is highlighted by a simple wood frame. A one-story shed addition projects from the east elevation. 615 Old Fall River Road is a modest mid nineteenth century Greek Revival cape.

### HISTORICAL NARRATIVE

According to assessors records, <u>615 Old Fall River Road</u> DAR.660 was constructed in 1860; however the property may appear on the 1856 map, although it is unlabelled. The property first appears on the 1895 map as the residence of J. Aldrick. Town records indicate that the property was owned by Alton D. Gifford Jr. (b 1903), a poultry man during the mid twentieth century with his wife, Susan (b 1903); however, no date is given. In 1979, the property was acquired by the current owners, Robert and Catherine E. Reed.
